Re: Kensington Police Department Officer Juan Ramos' Return to Work from Administrative

Leave

Officer Juan Ramos was previously placed on administrative leave pending investigation of potential misconduct deriving from an October 7, 2015 traffic stop of Vanessa Cordova, a member of the Board of Directors of the Kensington Police Protection and Community Services District. The traffic stop resulted in a citation of Ms. Cordova for expired registration and no front license plate, both "fix-it ticket" violations. In response to Ms. Cordova's complaint about the traffic stop, the matter was referred for independent investigation by the Richmond Police Department Internal Affairs Division.


The investigation inquired into allegations including improper access to the California Law Enforcement Telecommunications System CLETS. The investigation revealed that Officer Ramos engaged in one inappropriate CLETS access in advance of his investigative interview. This was a violation of department policy, but did not involve criminal misconduct.

In order to ensure transparency, I asked the Contra Costa County District Attorney's Office to review the investigation and CLETS access by Officer Ramos and determine if any criminal misconduct was committed by Officer Juan Ramos. By letter dated June 24, 2016, Paul Mulligan, Chief of Inspectors of the District Attorney's Office, determined there was no evidence that Officer Ramos committed any crimes involving the use of CLETS databases during the designated time period of July 1, 2015 through December 31, 2015. A copy of this letter is attached.

Given the conclusion that no criminal offense was involved, Officer Ramos has been returned from administrative leave to active duty, subject to potential discipline for violation of departmental policies. As your Interim Chief of Police, I am committed to ensuring Kensington Police Department employees are held accountable for any and all misconduct. As your Interim General Manager, I will ensure the police department maintains the highest level of ethical and professional service to the community.

Dear Chief Hart:

On April 10th, 2016 you asked the District Attorney's Office to investigate possible misuse of the California Law Enforcement Telecommunications System (CLETS) by Kensington Police Officer Juan Ramos.

Our office reviewed the internally generated spreadsheets provided by your agency, and we also analyzed California Department of Motor Vehicles (DMV), and Automated Regional Information Exchange System (ARIES) databases to assist in this inquiry.

Based upon our investigation, we did not find any evidence that Officer Ramos committed any crimes involving the use of the CLETS databases during the designated time period (July 1st, 2015 through December 31st, 2015).
