Hello KPPCSD Board Members,

I recently learned about a group of Kensington residents pushing for the KPPCSD board to adopt food waste collection/composting in CA. Thanks mostly to CA law SB1383 that begins January 1, 2022 and requires organics to be diverted from landfills, I understand that there is an updated contract in place with our trash hauler, Bay View, which will be brought before the Board on Thursday night for approval.

I just wanted to say that I encourage the board to adopt the revised Bay View waste contract so we can come into compliance with CA SB1383 and do our part to combat climate change. Here is why I believe we should adopt the revised contract:

1. Most cities around us in the Bay Area have offered curbside food waste pickup for many years. Kensington finally gets to catch up and join in!
2. When organics go to landfills, they release methane, a greenhouse gas 21 times more potent than methane. Although landfills do capture methane, food waste decomposes so quickly that all the methane is lost to the atmosphere before the landfill is capped and the methane is captured.
3. Just this past week at the Cop26 climate conference in Glasgow, President Biden unveiled a pledge to reduce global methane emissions by 30%. We all must do our part, and curbside composting is an easy way Kensington can reduce ghg emissions.
4. To those who say composting is smelly-no new material is being created. Instead of putting organic materials in your trash bin, they are going in the organics bin. Different bin, same materials.
5. To those who say this is more expensive-It looks like this will add \$5 to our monthly bills. \$5 is the price of a store-bought coffee. This rate increase is nothing when you look at the havoc and expense that climate change is wreaking. We know this well in CA from the enormous cost and destruction we have seen with wildfires, that have increased in size and intensity due to climate change. I am happy to pay this small increase to properly manage our materials.
6. There are many Kensington residents who are excited and have been waiting for this opportunity for years! I encourage the Board to adopt the revised contract with Bay View so we can come into compliance with CA SB1383 and start doing our part to combat climate change and create a renewable, value-added product by composting our food waste.
